A vegetarian option is also available. Included with lunch will be chef's choice for potato and vegetable. We conclude lunch with an ice cream sundae and coffee or tea.

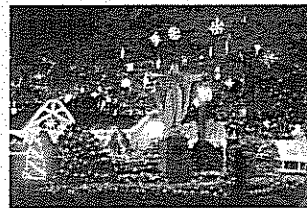

**Walking info:** on and off the coach, into and out of the mansion, restaurant and shrine. **Trip is rain or shine.**

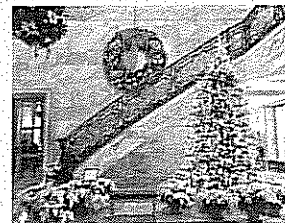
